Use to kill and control adult mosquitoes and other pests.

Effectively kills mosquitoes, ticks, flies, and spiders on contact in as little as 24 hours. **For Misting Spray, Compressed Sprayers and Fogging Applications:** Ensure sprayer nozzle/heads are selected to provide maximum coverage and ideal droplet size. Mix 0.5 - 2 ounces of this product per gallon of water; agitate to thoroughly mix.

If spraying large volumes, utilize recirculation or agitate periodically during application. For initial applications or when heavy pressure is noted, consider utilizing higher use rates from 2 - 6 ounces per gallon of water. For exceptionally heavy insect pressure or cleanouts the high rate of 6 - 10 ounces per gallon may be used. One gallon of mixture covers 4,000 - 6,000 square feet, depending upon vegetative density in the treatment area.

Reapply every 3 weeks (21 days), or as needed to achieve control. For best results, spray under shrubs, wood piles, leafy areas and anywhere that is shaded with moisture. Spray into trees, including up and under the leaves, where adult mosquitoes hide during the day. Treat harborage areas such as shaded structures, natural areas, and vegetation where mosquitoes may rest. Vegetation around stagnant pools, marshy areas, pools, recreation sites, and shorelines may be treated. Do not spray directly on bodies of water to include lakes, ponds, rivers, or other natural bodies of water. Dilute product may also be sprayed on, swing sets, patios, eaves, windows, doorways, docks, piers, porches, porch lights, and around utility boxes.

Product diluted per this label has not stained, discolored, or caused damage to painted or varnished surfaces, fabrics, or other surfaces in testing. Because not all surfaces were tested, it is recommended that user test treat a small, non-visible area and allow to dry, to determine whether staining or discoloration will occur. If over-spray lands on any sensitive surfaces such as fabric or porous plastics, rinse with water and wipe off with a clean cloth. Liquid soap may be used for clean up if needed. Product has not shown phytotoxicity in testing when used as directed. However, it is impossible to test for all plant types, so if concerned with phytotoxicity and sensitive plants, consider testing in small areas prior to broad use.

This product may also be applied using hand-held, hose-end, or backpack-type sprayers by following dilution directions above and sprayer manufacturer directions.
